Programme description: *The Master's degree 40.04.01 Jurisprudence programme was developed based on the Federal State Education Standard of Higher Education 3++ while also accounting for the needs of the regional labour market and the traditions and achievements of the Institute of Law and taking into account the requirements of federal legislation. The academic programme is aimed at the formation of universal and general and specific professional competencies as well as:*

- *developing knowledge in jurisprudence, problem solving skills;*
- *providing students with theoretical knowledge and practical skills in the legal support of commercial and non-commercial organizations, government and management bodies in order to form the necessary knowledge, skills, and abilities and account for the needs of the regional labour market, the traditions and achievements of the Institute of Law, while also taking into account the requirements of federal legislation;*
- *providing students with theoretical and practical knowledge in the field of legal support of the operation of commercial and noncommercial organizations, government bodies, and management, in order to form knowledge, skills, and abilities in the fields of law-making, law enforcement, analytics, consultation, management, teaching, and research;*
- *training highly-qualified and competitive specialists while accounting for the recommendations of employers and also developing the professional personal qualities of students required for this field;*
- *formation of knowledge, skills and abilities for the legal support of economic processes—from the creation of a business entity to its liquidation; protecting the rights of business and professional entities;*
- *forming universal competencies that contribute to the social mobility of graduates and their stability in the labour market;*

- *forming students' ability to work independently in a professional setting;*
- *future post-graduate studies.*
